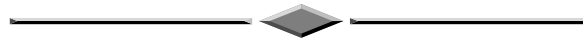

NOTICE IS HEREBY GIVEN that sealed Bids will be publicly opened, examined, and announced by the Soquel Creek Water District, Santa Cruz County, California, on July 11, 2006 at the hour of 2:00 PM and reported at the next regular District Board Meeting.

Bids may be delivered or mailed to the Secretary of the Board, 5180 Soquel Drive, Post Office Box 158, Soquel, CA 95073.

Bids shall be made in accordance with the prevailing hourly rate of per diem wages for this locality and project as determined by the Director of Industrial Relations pursuant to Labor Code §1770 et seq., a copy of which is on file at the District Office, 5180 Soquel Drive. Labor Code §1770 et seq. is made a part of this Notice by reference as though fully set forth herein.

The work will consist of installing 1,070 LF ± of 8-inch PVC C900 Class 200 water main, 3,668 LF ± of 6-inch PVC C900 Class 200 water main, 78 service replacements, 4 each 2-inch combination domestic/fire service reconnections, 1 each 2-inch fire service reconnection, 9 each existing domestic service tie-overs to existing mains, 3 new James Jones J-3740 hydrant installations, abandonment of 4 existing wharf head fire hydrants, installation of 3 permanent blow-off assemblies, 8 tie-ins to existing water mains, 71,180 SF of Type II slurry seal, and all other incidental work.

Work will be done and progress payments made in cash in accordance with the plans and specifications approved by the Board of Directors on June 20, 2006 and the Standard Specifications and Standard Plans adopted by the Board of Directors August 2, 1994.

The Board of Directors reserves the privilege of rejecting any and all bids or to waive any irregularities or informalities in any bid, or in the bidding process.

No bidder may withdraw his bid for a period of thirty (30) days after bids are opened, within which time an award will be made.
