- **Santa Cruz Local Agency Formation Commission (LAFCO)** – Rachél Lather, *term valid through May 2023*
- **Santa Cruz Mid-County Groundwater Agency (MGA)** – Dr. Tom LaHue and Dr. Bruce Jaffe (Rachél Lather is alternate), *appointments usually considered at the second Board Meeting in December*
- **Zone 5 Santa Cruz County Flood Control and Conservation District** – Dr. Bruce Jaffe, *no term limits, appointment usually considered at the second Board Meeting in December*
